**Registration is open for the DTD 2026-2027 school year!**

**As of spring 2026, we have adjusted our registration/tuition rates as follows:**

Registration for students in K–9 is \$400 and is non-refundable. Payment is due in full by May 30.  
After June 2, the registration fee increases to \$450.

*Students may not begin school on August 17, 2026 unless their registration fee is paid in full.*

**DTD is pleased to offer the following discounts to qualifying families to be applied in the order listed below:**

**CONSTITUENT/EMPLOYEE TUITION DISCOUNT RATE\*:**

Who is eligible: All adult members of the Lynchburg SDA Church and full-time DTD non-teaching staff members. Their K-8 grade DTD students may receive a \$270.00 discount per family. FTE Potomac Contract Teachers: Potomac Conference discount policies apply instead.

**MULTIPLE-CHILD TUITION ADJUSTMENTS\*:**

Families with more than one student enrolled at DTD will receive a 10% tuition discount for the second child.

For families with three or more children, tuition adjustments will be reviewed on a case-by-case basis to ensure support that fits each family's needs.

**MILITARY DISCOUNT\*:**

In honor of Desmond T. Doss, parents/legal guardians who are U.S. active duty or veterans qualify for a 5% off total tuition for siblings in an immediate family.

**PREPAYMENT OF ANNUAL TUITION DISCOUNT\*:**

A 10% discount is available to families who prepay the full annual tuition by August 17, 2026.

**ELIGIBLE FAMILIES MAY QUALIFY FOR A VIRGINIA TAX CREDIT SCHOLARSHIP IF FUNDING FOR DTD IS AVAILABLE.**

See the other side of this flyer to find out if your child is eligible to receive a scholarship toward tuition from this fund. If he/she qualifies this scholarship may apply each year thereafter, if the state of Virginia continues to participate.

\*Families receiving financial assistance are not eligible for additional tuition discounts. To ensure fairness and sustainability, the combined value of all adjustments is limited to a maximum of 20% of tuition.
